CONFERENCE REGISTRATION POLICIES

Registration

All attendees, including speakers and poster presenters, are REQUIRED to register for the conference and pay the registration fees. One-day fees are available on-site.

To receive discounted rates, members must be in good standing and membership must be current through March 2010.

Special discount for four or more professional members from the same institution or practice when submitted together by January 31: \$295/person. Call 240-485-1031.

Students, trainees, residents, and postdocs must include a letter from their institution to be eligible for special reduced fees. Guest fees are for nonprofessional adult family and guests accompanying registrants and provide access to nonticketed meals and receptions.

Consumers must register by phone at 1-800-922-8947 ext.131 or register on-site. Consumer rates are not intended for health professionals, faculty, or research staff.

Only registered professional attendees can receive CE/CME credits; those paying guest, student, or consumer fees cannot apply for CE/CME credits. Except for ticketed events, there is no fee for children under 18.

Registrants will receive confirmation by e-mail. All registrants will receive their badge and conference information three weeks prior to the meeting and must bring these to the conference. Badge holders and programs will be handed out on-site. Badges must be worn at all times.

Cancellation

Cancellation notice must be received in writing by January 29, 2010. A \$75 administrative fee will be charged for all refunds. Ticketed events cannot be cancelled. Due to the many costs associated with planning and organizing this conference, cancellations are NOT accepted for any reason beginning January 30. Refunds will be issued after the conference.

Payment
